

Careers Statement and Provider Access Policy

Introduction

This policy statement sets out Glebelands School's arrangements for managing the access of providers to pupils at the school for the purpose of giving them information about the provider's education or training offer. This complies with the school's legal obligations under Section 42B of the Education Act 1997. We are committed to meeting the requirements of the 8 Gatsby benchmarks.

Student entitlement

All pupils during school years 8 to 11 will have opportunities to meet a range of providers of approved technical education qualifications and apprenticeships and are entitled to:

- Two encounters for pupils during the 'first key phase' (year 8 or 9) that are mandatory for all pupils to attend, to take place any time during year 8 or between 1 September and 28 February during year 9.
- Two encounters for pupils during the 'second key phase' (year 10 or 11) that are mandatory for all pupils to attend, to take place any time during year 10 or between 1 September and 28 February during year 11.
- Find out about technical education qualifications and apprenticeships opportunities, as part of a careers programme which provides information on the full range of education and training options available at each transition point
- Hear from a range of local providers about the opportunities they offer, including technical education and apprenticeships through options events, assemblies and group discussions and taster events
- Understand how to make applications for the full range of academic and technical courses
- These opportunities must be for a reasonable period of time during the school day
